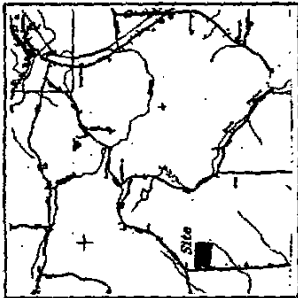

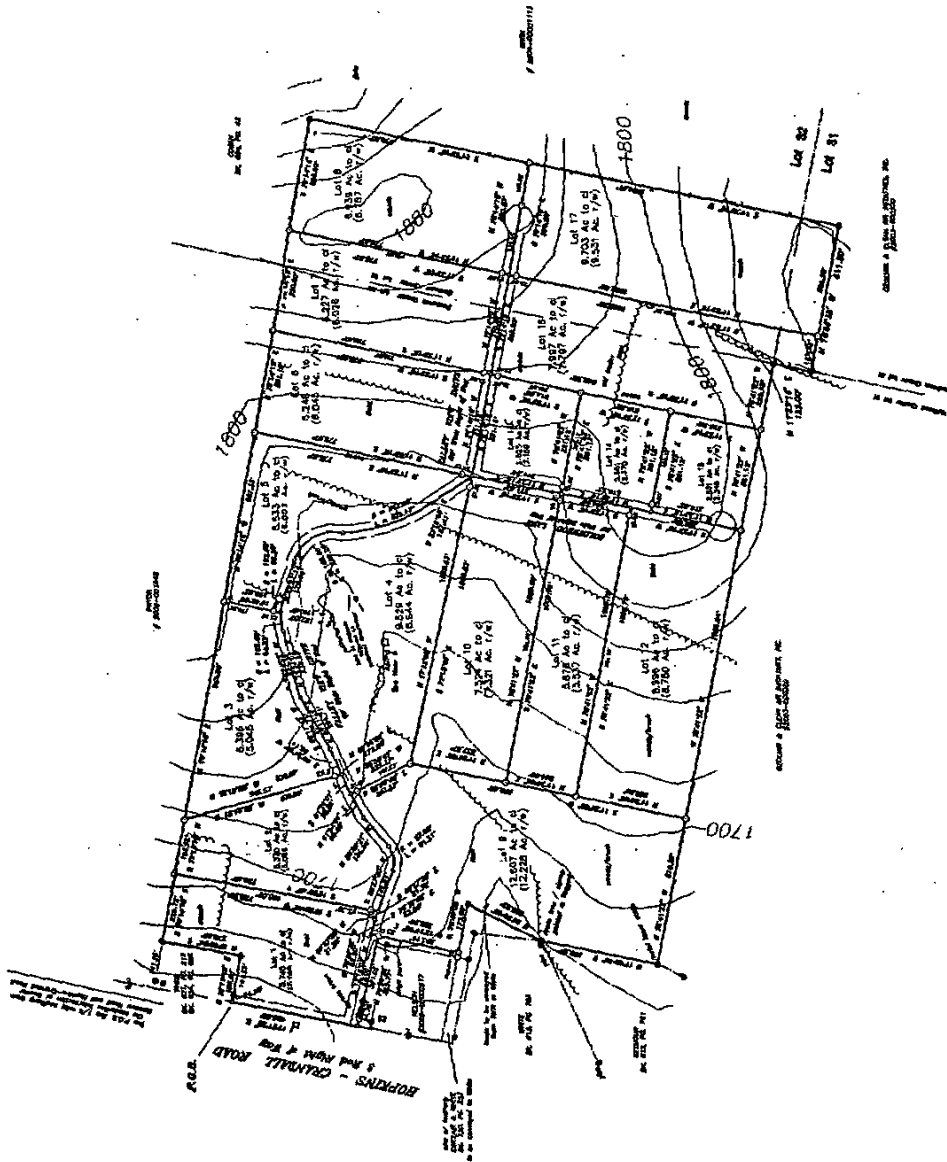

Location Map



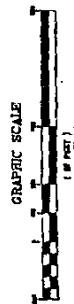
